8. Supervisor's Remarks and prepared remarks from Cemetery Board President

<u>Supervisor Lee Jennings</u>: The Township is financially sound. We are cutting taxes when post ble. We have built up reserves and are doing well.

Sue Congdon, President of the Nunda Township Cemetery Board's prepared remarks: Our board consists of three people, myself, Ann Wells, Secretary and Leda Drain, Treasurer. We oversee four cemeteries – Holcombville, Ridgefield, McMillan and Prairie Grove.

As of the beginning of March, the checking account had a balance of \$47,768.56 and the mousy market account had \$50,050.25. There were twelve sites sold/or burials in 2016.

Some of the sites were previously sold and used later. Our current price is \$450, which includes the site and the permits required. All sales now require an on-site inspection by staff and purchaser.

This year our main focus is maintenance and upgrades. We have plans to install columbarium is at Holcombville and Prairie Grove. This will allow options for people not wanting a traditional curial. Along with those installations, we will landscape the areas involved. We are also planning on marking each grave with identifying information this summer. This particular project was put on hold last year

and the hope is to complete by year end. We will also begin replacing cemetery signs. New esigns and new signs will be done on an as needed basis, with the expectation that they will all be replaced soon. Maintenance at each cemetery is on-going. We try to stay on top of dead trees, plantings that have gotten out of hand, road repair and other maintenance issues.
