5. Public Comments (as related to Agenda items only) - Residents stated the following: Bob Schultz of S. River Road, McHenry - Thanked the Board his roads are in best shape it has ever been in - has used mulch program, brush drop off and recycling program. Rd Commissioner has helped with sand bags to Holiday Hills. Scott Brinkmann of Oakwood Lane, C.L. - Resident for 22 years nothing was done with roads in the past - things have been corrected, repaired and miraculous. Greg Shutt of Little Drive, McHenry - Roads are in best condition - thanked Rd Commissioner. Rich Schwan of S. Lilly Lake Road, McHenry – stated road commissioner is a good worker and isn't afraid of getting dirty. Greg Tricker of Nancy Lane, McHenry - Has dealt with flooding problems for fifteen years and couldn't get previous road commission to get anything done. Rd Commissioner Lesperance took time to see the problem, make a quick fix and this was the first summer with no water problems. Bob Sexton of S. Fernwood Lane, McHenry - thanked the Rd Commissioner for progress and for great job on last snow fall. Progress works - finally found someone who made it work. Michael Walkup - of Walkup Road, C.L. - County Board member - said property tax in McHenry County is in the top 1% - County gets the blame but multifaceted - needs everyone. McHenry and Algonquin Townships as well as the City of McHenry decreasing Levy 10%. - let's decrease our Levy

<u>Jennings</u> – Waster Management's leaf vacuuming finished – went well.

Supervisor inducted into Univ. of IL's Extension Program's Hall of Fame for the Nunda Garden.

Township has received a grant from the McHenry County Health Dept. for a green house.

Koscavage- Reported on Consolidated Primary updates and petitioning.

Dzemske - Packets of monthly report available online under Assessor. Clarified previous Assessor did not replace any employees - two have retired and they are still down one staff person.

Shorten - Referred to the line item (for Budget) for T.O.I. - Township should look at T.O.I.'s worth they tend to lobby things. T.O.I.'s annual conference included topic, "Communicating Your Election Message." Jennings stated it's a requirement for the TORMA Insurance to participate in T.O.I.

Boltz - Townships of Algonquin and McHenry have five million dollars and can cut budget by 11%.

They are in a lawsuit to reimburse residents. Nice to have a "war chest" but not doing any good would eliminate library tax vs. Township cost.
